Máa sá iyatee,

- Getting enough sleep
- Developing coping skills

Early Warning Signs

Not sure if you or someone you know is living with mental health problems? Experiencing one or more of the following feelings or behaviors can be an early warning sign of a problem:

- Eating or sleeping too much or too little
- Pulling away from people and usual activities
- Having low or no energy
- Feeling numb or like nothing matters
- Unexplained aches and pains
- Feeling helpless/hopeless
- Increase in substance abuse
- Feeling unusually confused, forgetful, on edge, angry, upset, worried, or scared
- Fighting/yelling with family/friends
- Severe mood swings
- Inability to perform daily tasks
- Thinking of harming yourself or others
- Hearing voices or believing things that are not true.

TTC Annual General Assembly Resolutions

Resolution # 2020 - 001

Approval of Agenda - passed

Therefore be it resolved that the agenda is approved with changes as outlined in this resolution.

Resolution # 2020 - 002

General Council Procedures (in Person and Virtual) - passed

Whereas TTC is exercising protective measures, informed by the Yukon Chief Medical Officer's directives, to safeguard the health of Teslin Tlingit, staff and contractors in response to the COVID-19 pandemic.

Therefore be it resolved that the General Council authorizes the meeting procedures of September AGA be conducted in person and virtually with the support of video or teleconferencing methods.

Resolution # 2020 - 003

Approval of General Council Minutes: (February 2020 and July 2020) - passed

Therefore be it resolved that the General Council approves the GC minutes with no additions, deletions or revisions.

Resolution # 2020 - 004

Housing Committee Appointments (September 2020 - November 2022) Yanyeidi appointment

Whereas the seat for Yanyeidi are currently vacant on the Teslin Tlingit Housing Committee; Yanyeidi have nominated Martina Sidney and have confirmed Martina's interest to serve on Housing Committee.

Therefore be it resolved that the General Council confirms the appointment Martina Sidney

(Yanyeidi representative) to serve on the Housing committee effective immediately to November 2022.

Resolution # 2020 - 005

Consultation and Final Approval of LINGIT YOO X'ATANGI KA HAA SHAGOON - passed

Whereas the General Council enacted the Lingit Yoo X'atangi ka Haa Shagoon law (the law) for the revitalization, protection, advancement and increased access to Lingit for Teslin Tlingit citizens (resolution #2017-009). The law was suspended to come into full force to satisfy the consultation obligation with the Government of Yukon pursuant to section 13.5.5 of the Teslin Tlingit Council Self-Government Agreement. Consultation with the Government of Yukon has been concluded in March 2019 and technical amendments have been identified and require consultation in accordance sections 49 and 48 of the Administration and Interpretation Act. In the interest of bringing the act into full force and effect at the proposed General Council meeting of November 2020, Executive Council proposes a) that the consultation for the purpose of section 48 be completed by virtual and in person, subject to COVID-19 limitations by October 30, 2020 and b) that the 60 days and two week requirements set out in section 48 be waived by the General Council. Therefore be it resolved that the General Council hereby approves the Executive's recommendation as set out in item 4 and the Executive's recommendations be presented to the Gen-

eral Council meeting scheduled for November 2020, subject to the conclusion of the consultations as set out in section 4 (of this resolution), for the General Council members' consideration and final approval, if appropriate.

Resolution # 2020 - 006

Affirmation of Candidates Elected to Office: Naa Shaade Hani and Deputy Naa Shaade Hani - passed

Whereas 1. The Chief Electoral Officer appointed under the Naa Shaade Hani awe kaa kaa wudsageedi - *the election of a leader (the act)* declared Eric Morris as the candidate receiving the greatest number of votes and is elected to the office of the Naa Shaade Hani in accordance with 121 of the said act. 2. The Chief Electoral Officer declared Alex Oakley as the candidate receiving the greatest number of votes and is elected to the office of the Deputy Naa Shaade Hani. 3. Section 170 of the act confirms that the candidates confirmed in accordance with section 121 are to take their Oaths of Office and assume their duties as the Naa Shaade Hani and Deputy Naa Shaade Hani on October 15, 2020. Therefore be it resolved that the General Council hereby affirms Eric Morris as the Naa Shaade Hani and Alex Oakley as the Deputy Naa Shaade Hani to serve on the Executive Council for the purpose of section 11.2 of the teslin Tlingit Council Constitution. Be it further resolved that considering the conflict between section 170(1) of the act and sections 9.5 and 11.3 (a) of the TTC Constitution, the General Council hereby affirms that con't

Eric Morris and Alex Oakley will assume their duties as the newly elected Naa Shaade Hani and Deputy Naa Shaade Hani on September 25, 2020 following the taking of their Oaths before the General Council.

Resolution 3 2020 - 007

Confirmation of General Council Members (2020 - 2024) - passed

Whereas 1) Each Clan is to select five representatives, that includes their appointment to the Executive Council and the Youth Council to serve as members of the General Council every four years at the Annual General Assembly, in accordance with section 9.1 and 16B.5 of the TTC Constitution.

2) The Yanyedi have nominated Madeline Jackson, Margaret Bob, Georgina Sydney and Savana Kremer as the Youth member, in addition to their Executive Council member Duane Gastant' Aucoin to serve as Yanyedi GC members for a term of four years, 2020 - 2024.

3) The Dakl'aweidi have nominated Roger Smarch, Roderrick Dewhurst, Carol Geddes, and Billy Smarch as the Youth member, in addition to their Executive Council member Dalcyce Huot to serve as the Dakl'aweidi GC members for a term of four years, 2020-2024.

4) The Ishkitan have nominated Kristyne Geddes, Sam Johnston, and Destiny Taylor as the Youth member, in addition to their executive Council member Blair Hogan to serve as the Ishkitan General Council members for a term of twelve months.

5) The Kukhhittan have nominated Charles Jules, Randy Keleher, Davida Wood and Christopher

Fairclough as the Youth member, in addition to their Executive Council member Sandy Smarch to serve as the Kukhhittan GC members for a term of one year (Sept - 2020 to the next scheduled Annual General Assembly for 2021).

6) The Deshitan have nominated Delores Jackson, Berdina Hager, Mickayla Wolfe and Daniel Hager as the Youth member, in addition to their Executive Council member Kyle Keenan to serve as the Deshitan GC members for a term of four years, 2020-2024. Melaina Sheldon and Marijane Vance are the alternates. &) Each of the named nominees have accepted their nominations to serve on the General Council. Therefore be it resolved that the General Council confirms that with the exception of those appointed as representatives for Kukhhittan and Ishkitan Clans, the persons named in this resolution are hereby confirmed as the GC members for a term of four years, following the taking of their Oaths of Office. Be it further resolved that the persons names for the Kukhhittan and Ishkitan Clans hereby confirmed as the GC members for a term of one year (Sept 2020 to the next scheduled Annual General Assembly for 2021).

Resolution # 2020 - 008

Confirmation of Executive Council members & Executive Elder (2020 - 2024) - passed

Whereas in accordance with section 10.3 of the Teslin Tlingit Council Constitution each Clan will select one representative to be appointed as a member of the Executive Council every four years at the Annual general Assembly.

Therefore be it resolved that the general Council confirmed five persons as the Executive Council, following the taking of their Oaths of Office.

Resolution # 2020 - 009

Establishment of TTC Working Committee: Legal and Constitutional Matters (2020 - 2023) - passed

Whereas in accordance with Resolution #2020.07.11.004 General Council directed the establishment of a clan based working committee to undertake the following specific legislative and constitutional matters: a. Complete the legal and technical drafting of Haa Kusteeyi and present to the AGA 2021. b. Complete a comprehensive legislative review of the Naa Shaade Hani awe kaa kaa wudsageedi - *the election of a leader (the act)* and the 2020 leadership selection process and develop recommendations to the GC at the AGA for 2024 leadership selection process. c. Review the Teslin Tlingit Constitution with a purpose to provide recommendations to strengthen the clan-based government. The Clans are encouraged to appoint those clan members who have knowledge of Haa Kusteeyi. Dakl'aweidi have appointed Sheila Clark, Ishkitan have appointed Anne Turner, Kukhhittan have appointed Sandy Smarch, Deshitan have appointed Marian Sheldon and Yanyedi have appointed Georgina Sydney; all for term of three years (2020-2023).

The General Council seeks to ensure that the Elders Council and Youth Council are represented on the working committee, the Elders and Youth Councils will bring forward their appointments to the working committee at the November 2020 GC meeting. Each individual identified as appointments have accepted and are prepared to serve on the working committee for a term of three years. Therefore be it resolved that the GC confirms the individuals identified, the Executive Council office to provide the legal and technical assistance to the working committee when appropriate and the Working Committee is to prepare and present a draft term of reference to govern the working committee's work for the General Council's consideration and approval at the November 2020 GC.

Resolution # 2020 - 010

Teslin Tlingit Council (TTC)

Supplementary Budget 2020-2021 Fiscal Year - approved

Whereas The Executive Council presented and tabled the TTC departmental work plans (2020/21) and an Operating Budget estimate for 2020/21 in the amount of \$22,167,299.00 to the General Council in Feb. 2020. The GC approved the Operating Budget as confirmed by resolution # 2020.02.26.05. The Executive Council and Finance Director have presented a request for additional monies to the GC for 2020/21 fiscal year, as a supplementary to the Operating Budget. The Executive Council Office and Finance Director are recommending that monies

from the FTA reserve (2019-20) be applied to cover the expenditures in the amount of \$160,000.00 as requested in the supplementary budget for 2020/21 and Executive Council Office and Finance Director recommends that TTC enter into a loan agreement with Yukon Government for subdivision development in amount of \$50,000.00. Therefore be it resolved that the GC approves the supplementary budget in the amount of \$210,000.00 as recommended by the Executive Council Office and Finance Director.

Resolution # 2020 - 011

Approval of Architectural Design: TTC Community Services Building - passed

Whereas the General Council mandated Executive Council to begin preparations and identify financial resources to construct a new administration building. The GC authorized the Executive Council to access an existing TTC line of credit to fund the architectural design and planning costs of the TTC administration building, up to a maximum of \$2,200,000. plus interest. Canada has committed to reimburse TTC in the amount of \$6,954,235.75 for negotiation loans TTC had paid to Canada respecting the Yukon TTC Final Agreement, payable in five equal installments commencing with the current fiscal period. TTC has retained the professional services of DNA/KZA as the architects to design the proposed TTC community services building. DNA/KZA advised that the proposed community

services building original design was modified to provide for additional space and allow for growth within the building. The modifications increased the value of the project from 27.5M to 30.5M. Director of Lands presented architectural designs, developed by DNA/KZA for General Council's consideration. The Director of Lands presented that the construction of building will cost an additional 3.3M. The Lands department and DNA/KZA require GC to approve an architectural design. General Council require additional details that confirms costs associated with the increased expense. Therefore be it resolved that GC directs Executive Council coordinate and attend an All Citizens meeting and invite DNA/KZA to attend and present design. The Executive Council is authorized to make a final decision on final considerations to inform GC Nov. 2020. Be it further resolved that Executive Council is directed to present a financial proposal with recommendations to address the increased construction cost to the General Council in November 2020 for further deliberation and approval.

Resolution # 2020 -

012 Deferral of Future DDC Reports to the NGA General Council Meetings - passed

Whereas The Deslin Development Corporation (DDC) was established in 2013 to advance economic development opportunities with other governments (Yukon, Municipality and First Nation) and business entities to advance con't

Teslin Tlingit community economic development and capacity. General Council directed the DDC Board to provide annual reports at the AGA meetings, it is more appropriate for DDC reports to be presented at the NGA General Council meetings. Therefore be it resolved that all future DDC annual reports be presented at the annual Non-Governmental Assets GC meetings.

**Resolution # 2020 - 013
Confirmation of Mandate and Timelines: Off Settlement Land Working Group - passed**

Whereas the GC established a working group in November 2013, 'OSLWG' to identify the program service needs of Teslin Tlingit citizens who reside off TTC settlement Lands. The GC reconfirmed the OSLWG mandate at the July 2016 AGA. General Council seeks to clarify and qualify the OSLWG mandate and provide appropriate timelines to conclude the OSLWG work in order that Executive Council and Management Board may access the information to inform future TTC program development and service delivery for TTC citizens. Therefore be it resolved that a) OSLWG prepare and present an operations budget and workplan to the Executive Council and Management Board to continue the OSLWG work for the 2020/21 fiscal period. b) OSLWG prepare and table an interim report to the GC for the February 2021 meeting; c) OSLWG prepare and table a final report to the GC at the AGA 2021.

**Resolution # 2020 - 014
Director Appointment for Tle' Nax T'awei INC: yanyedi - passed**
Whereas Roland Gergel, a director representing the Yanyedi Clan for Tle, Nax T'awei Inc has resigned effective September 26, 2020. The Yanyedi have nominated Richard Sidney to assume the duties as the director representing the Yanyedi Clan on the Tle' Nax T'awei inc board of Directors effective September 26, 2020. The procedures for clan appointments to the board of directors is: each clan nominates their candidate, GC approves the nominated candidates and the TTC Business Trust, as the shareholder confirms the appointments. Therefore be it resolved that the GC hereby approves Richard Sidney as the nominated candidate to represent Yanyedi on the Tle' Nax T'awei board to assume duties effective September 26, 2020 and to serve for the remainder of Yanyedi term.

BC Treaty Negotiations update

Happy Thanksgiving Folks

I presented the following update to the General Council at our 2020 Annual General Assembly on September 25.

“We, the Teslin Tlingit, are historically connected as Inland Tlingit with the Taku River Tlingit First Nation (TRTFN), Carcross/Tagish First Nation (C/TFN). We are the Dahk Ka Nation.

In keeping with this connection, we are working towards rebuilding our Dahk Ka Nation by developing a shared vision and “structure” that will strengthen our common values and also support individual aspirations and focus as individual Nations.

Rebuilding Dahk Ka Nation

The Rebuilding the Nation Steering Committee is comprised of the three Chief Negotiators. We received funding from Canada to assist us in Rebuilding our Dahk Ka Nation. TTC will be administering these funds.

The Dahk Ka Nation Caucus is developing a shared vision that will guide the Nation on how we support each other and work together while recognising our individual needs and aspirations. We plan to do this by connecting with each community individually and collectively.

The team met with Leadership in August 2020 who supported our work to date and our proposed work plan which includes:

- Building a Tlingit Caucus;

- Gathering existing information about Dahk Ka from our 3 First Nations including the direction that we received from our Elders over the years.

- Hiring a coordinator to keep our 3 First Nations connected and working together.

- Hiring a firm to assist us in organising and documenting virtual and in person gatherings with our Citizens, Elders and special emphasis youth to get their input on how they envision the Dahk Ka Nation in the future.

While doing this internal work, the TTC and C/TFN are negotiating with Canada and BC for a treaty regarding their traditional territory in northern BC and the TRTFN is negotiating with Canada and Government of Yukon regarding their traditional territory in the Yukon.

BC Negotiations

C/TFN and TTC’s mandates are clear. We are mandated to ensure that our respective First Nations have one treaty law across the spectrum of our traditional territories which include the provisions of the United Nations’ Declaration on the Rights of Indigenous Peoples (UNDRIP) and the “Truth & Reconciliation Report” recommendations and the evolution of the common law.

The TRTFN team (Lead Negotiator as well as lands managers and technical people) are invited to participate in the negotiations process as observers. The TRTFN Lead Negotiator, Chantelle Schultz,

is a participant at caucus and at the negotiation table.

Since we have started negotiations, we have made notable progress.

On September 30, 2019, TTC, C/TFN and TRTFN Leadership met with BC Premier, John Horgan, in Whitehorse where he requested that we work with his negotiating team until such time as he could fulfill his electoral promises.

With that in mind, on November 26, 2019, TTC and C/TFN tabled a land related proposal to the BC government to establish an interim treaty arrangements and/or measures, based on collaboration amongst the First Nations, Canada and the Province, to ensure that our Aboriginal rights and titles are protected.

After many discussions with our counterparts, we are happy to report that the elements contained in the proposal are being addressed.

- We are moving forward in developing a Shared Decision-making Agreement;
- We are negotiating an Incremental Treaty Agreement for a Game Guardians Program in BC; and
- We are now addressing Land Use Planning through Canada’s Treaty Related Measures program which supports specific projects such as Land Use Planning.

TTC’s 2021-2022 BC negotiation budget was approved by the BC Treaty Commission.

Conclusion

Our immediate priority is to establish a Teslin Tlingit Caucus in order to ensure a common voice and direction.

This is exciting times as we solidify our Dahk Ka Nation and pursue our negotiations to protect our rights, titles and interests in northern BC.”

Current Context

From our inaugural meeting in December 2017 where TTC & C/TFN notified both Canada and Provincial negotiators of our intent to protect our rights title and interests in northern BC to our most recent negotiation session on September 24th much has changed on the political landscape.

Premier Horgan has called an election for October 24, 2020 seeking a majority Government. It has been a long & enduring journey to get to this point in negotiations under the former Liberal administration mandate. With a minority government it has been difficult for the NDP cabinet to reflect in policy the mandate that got them elected in May 2017. If the NDP win a majority government it will be a matter of re-engaging the political leaders and resume negotiations under a jointly developed mandate.

In the event of a change in government TTC & C/TFN is well positioned by having tabled a draft AIP & transitional MOU to stage 5, the final agreement stage.

As First Nations governments our approach to negotiating modern Treaties continues to flow from “Together Today for Our Children Tomorrow” (Gunalcheesh Sam). As a team we recognize that in order for our nations to succeed we must continue to reach out and strengthen our relationships at every level of government, this attitude will continue to serve and to strengthen our relationship in a symbiotic manner. The TTC L&R’s department has taken great strides in working with their counterparts from Smithers BC and have successfully secured a funding commitment for a moose survey in northern BC.

Our immediate priority as a team is to host a public meeting with the intent of identifying and structuring a caucus that will guide us going forward. The Teslin campus opened back up on September 1st after being closed for several months due to COVID. Like everyone else, we are working to adjust our programming to meet local needs during uncertain times. The big news is that we are now a University and we have new staff! We also have an exciting multi-week program starting in the new year.

We have a new face on campus. Teresa Ward, who is familiar to many in Teslin, joined the campus in September as the Community Campus Liaison. She is with the campus part-time, and you will see her out and about in the community. Gord Curran remains as our longtime Instructor/Coordinator.

We just received news that we have funding to run an exciting new multi-week program in the new year. The Yukon First Nations Art Program will run from mid-January to early-April on Mondays through Thursdays from 9am to 4pm. The 12-week program is open to learners interested in developing their artistic skills in Indigenous visual arts. It includes six hands-on two-week modules, including beadwork, sewing, traditional footwork, and other Indigenous art. Each module is delivered sequentially to ensure students' learning experiences build on and further their artistic abilities. Students will be evaluated on their ability to produce high-quality products. The program will also include aspects of the business of art. We are also looking to hire local Teslin Tlingit instructors for the program.

Turning to the rest of our planning, not surprisingly, our 2020-21 planning was disrupted by the pandemic, causing our campus staff to scramble to reschedule courses and deal with COVID measures. Here is an update on some of the scheduling:

Credit students

We have around eight students taking credit courses in Teslin from about four different programs, with four students attending courses regularly on campus.

Safety Courses

Standard First Aid - The campus has standard first aid courses scheduled for October and November, with another two potentially to be scheduled after Christmas, depending on the need. We can have no more than nine students.

WHMIS, Fall Arrest, Rigging/ Hoisting, Transportation of Dangerous Goods, Traffic

Control Person – With the bridge construction project and several other infrastructure projects slated to start next summer, we will be delivering at least one round of these safety courses and possibly more, if needed. These courses will occur in the spring of 2021.

Chainsaw – We will be scheduling a chainsaw safety in the spring as per our regular rotation to update tickets.

Bobcat Safety – This course will be scheduled in the spring.

Food Safe – The campus is working on scheduling a distance offering of Food Safe with another community campus.

Contract Professional Workshops

The campus is coordinating several contract courses between TTC and YukonU Ayamdigut-based departments, including courses in leadership, supervisory, conflict resolution, investigation, and project management.

Public Workshops and Courses

The campus is also offering the following professional and general interest workshops to the public.

Excel 1 – This is scheduled to be delivered in November through a partnership with YukonU Continuing Education.

Bookkeeping – This course is tentative at this time. The campus is in discussion with YukonU Continuing Education about the possibility of delivering this training sometime this year.

Master Gardener – The campus plans to deliver this program in the spring in partnership with YukonU Continuing Education.

However, we wish to again remind you that our programs are not meant to simply serve as child care. The goal of our programs is to foster skill development, cultivate interests, and be a safe and positive environment for participants. As such, we have changed the structure a bit and ask that parents only sign up kids who are genuinely interested in the program and activity being offered. These are not simply drop-in programs.

We will maintain the following after-school programs, running from 3:30-5pm, in October.

Tuesdays – **Kids in the Kitchen** – age 8+ - at the Rec Plex.

Wednesdays - **Kids Club** –age 6-9 - at the Rec-Plex

Wednesdays – **Girls Club** –age 9+ - at the Rec-Plex

Friday – **Archery** – open age – at the Rec Plex

Our **Community Art Program** running Wednesdays from 6:30-9:30pm has continued to see great turn outs and creative outputs. We continue to seek local artist to help deliver different art projects each week. This could include paintings,

beading, carving and any other creative works. A longer painting workshop facilitated by Tara Easley was offered Sept 25 & 26, and we will look towards offering more of these sorts of sessions as we continue the Community Art Program through the fall and winter.

We ran a Salmon Jarring workshop September 11th & 12th. Rachel Blake shared her knowledge of cutting, preparing and jarring Salmon with the group of 10 people, whom all got to take home a case of jarred salmon at the end.

Facilitators from BYTE and Skills Yukon came to town on Sept 18 to run leadership activities with the youth. We had a good turn out, which is encouraging as we have continued to see some limited engagement from the teenage group here in Teslin.

We will return Friday nights to youth age 10+ to come hang out in the **Youth Center** (located in the curling rink viewing area) from 7-9pm. Saturday nights has been turned over to what have been well attended **movie nights** in the Rec Plex. We will announce a movie selection to appeal to different audiences (ie. Family movie, action movie, etc) each week.

We will be moving our Wednesday **Pickle Ball** in to the Rec Plex starting in October as we start making ice and preparing the

arena for the winter. Pickle Ball will lead into our Wednesday afternoon **Seniors Social** making it a great day for Seniors to gather to carpet bowl, play cards, and just enjoy a social afternoon.

We will be running a Halloween **Craft Night** on Thursday nights in October. We will work on making props and decorations for Halloween and a tentative haunted house we are hoping to run at the end of the month. Stay tuned for Halloween event announcements in October.

We wish to remind everyone that we must maintain the COVID guidelines of social distancing, regular hand washing, and maximum #s within our recreation programs. We recognize the increased difficulty in which this is becoming for participants, and in particular the youth and please ask parents to help remind youth of the necessity of VoT Recreation to operate within the guidelines imposed by the Yukon Government.

Project Update



We're still on track!

There is no denying that 2020 has come with its set of challenges. We've seen border closures, reduced travel and increased physical distancing measures, all paired with a number of new health and safety guidelines. Despite all of that, we are proud to have been able to stay on track and on schedule with the Nisutlin Bay Bridge replacement project.

Over the summer, we completed a geotechnical investigation, where we sampled the soil at the bottom of the bay from the bridge deck. The information we collected from this study has been critical to the design. We have also had initial discussions with the Yukon Environmental and Social-economic Assessment Board (YESAB) and will be working closely with them in the coming months to further develop our application package.

As we get closer to completing the proposed design of the bridge, we will be looking for your valuable feedback. While COVID-19 has prevented us from gathering in person, we will work closely with the Village of Teslin and Teslin Tlingit Council to coordinate the best way of sharing this information with you later this fall. Our goal is to have the design finalized by February 2021 with construction beginning later that summer. Stay tuned for more details!

Can my child go to school?

COVID-19 guidance for children six years and older.

Talk to your child every day to see if they have any new or worsening symptoms.

If your child has mild symptoms, they still need to self-isolate at home, but you can keep them at home for 24 hours to see if they get better or if new symptoms start.

Pre-existing conditions don't apply. For example, a child with asthma may have a cough, and some children get frequent runny noses during cold weather. You might want to talk to your child's teacher about what is normal for them.

RED symptoms

Cough
Fever/chills
Shortness of breath or difficulty breathing
Loss of taste or smell

YELLOW symptoms

Headache
Runny nose or congestion
Sore throat
Acute/intense fatigue
Generalized muscle aches (not related to physical exertion)
Significant loss of appetite
Nausea/vomiting
Diarrhea



If your child has **one or more RED** symptoms, **testing is STRONGLY recommended. They must NOT attend school until tested and the result is negative.**

If you don't have your child tested:
They must self-isolate for 10 days from the beginning of symptoms, even if the symptoms clear up sooner than 10 days.



If your child has **two or more YELLOW** symptoms for more than 24 hours, **testing is recommended. Your child must NOT attend school until you get their test results from your health care provider.**

If you don't have your child tested:
If symptoms clear up sooner than 10 days without testing, self isolation is still required unless you are told otherwise by your family physician or your rural primary health care centre.

If your child has **only one YELLOW** symptom they **can return to school when symptoms go away.**

Exceptions: If your child is **throwing up or has diarrhea**, keep him/her at home until 24 hours after symptoms have gone away.

If **runny nose/nasal congestion** lasts longer than 24 hours, is mild and not getting worse, and the child is otherwise well, they may resume regular activities including attending school or work.

You don't need a written note from your health care provider for your child to return to daily activities.



Your child has NO symptoms.

Your child can go to school.

Continue to encourage to them to follow the Safe 6.

This guidance DOES NOT apply if:

- Your child is a contact of someone who has COVID-19.
- Your child is severely immunocompromised or has a complex medical history.
- Your child recently returned from travel outside of Yukon.

Practise the Safe 6

Practise the Safe 6. Follow the 6 steps to staying safe and prevent the spread of COVID-19.

Maintain physical distancing – keep 2 metres (6 feet) between yourself and people who are not in your social bubble.

2

Wash your hands frequently with soap and water or use hand sanitizer with at least 60% alcohol.

Stay home if you're feeling sick.

4

Follow gathering guidelines

Remember to keep 2 metres (6 feet) between yourself and people who are not in your social bubble.

Indoor social gathering

Limit your group to 10 people even if they're part of your 15-person social bubble.

Outdoor social gathering

Limit your group to 50 people.

Organized indoor gathering in a big facility

Limit the size of your group to 50 people.

Organized outdoor gathering

Limit the size of your group to 100 people.

Read the complete gathering guidelines.

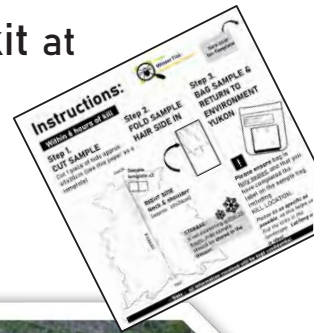

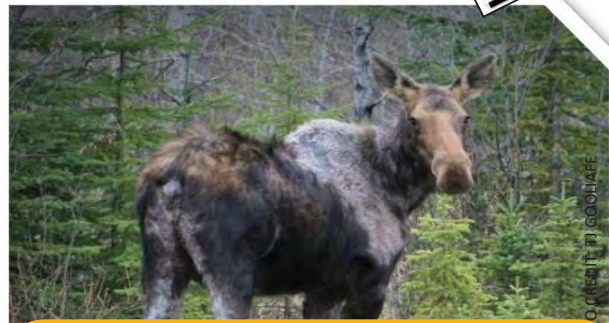

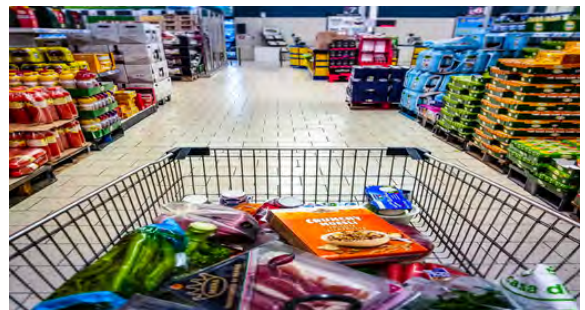
